



TRUCK RENTAL POLICIES & PRICING

Thank you for your interest in FMI's Rental Fleet. Following is a summary of our rental policies and procedures. If you have any questions or would like to rent a truck, please contact Charlie Turner in our Rental Department.

HOURS OF OPERATION

Scheduling and insurance requirements must be completed during business hours.

Our Rental Department is open from **8:00 AM to 4:30 PM, Monday through Friday**

When **pre-arranged** with rental department personnel, our rental trucks can also be picked up from our service department Monday through Friday from 4:30 PM to 11:00 PM.

BILLING

Our Rental Department operates on a monthly billing cycle. If you do not have an established open account with FMI, you may apply for an account by completing a Credit Application. We also accept major credit cards.

An invoice will be mailed to you on a monthly basis. **Invoices are due in full by the 10th of the month following the invoice date.**

FUELING

All units will be provided with a full tank of fuel. Vehicles not returned full of fuel will be refueled at a cost of **\$7.00 per gallon** (Note: The refueling charge is subject to change). This refueling charge will be included on your final invoice.

CLEANING

All units will be provided clean and free of debris. Smoking is strictly prohibited in our rental trucks. Vehicles not returned clean and free of debris, or smelling of smoke are subject to a **\$300.00 cleaning fee**. If the vehicle is determined to require a cleaning charge at check in, the \$300.00 cleaning fee will be included on your final invoice.

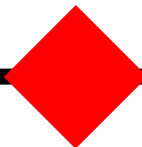
TAX

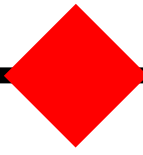
Multnomah County charges a **17% tax on rental trucks**. This tax is calculated on the rental rate only and does not include mileage charges, refueling, or cleaning charges (if any). The tax does not apply to vehicles over 24,000 GVW, long term rentals (over 30 days), or if you are renting from us because your vehicle is in our repair shop and is unusable.

LATE FEE

All rental vehicles must be returned by 11:00 AM on the scheduled return date to avoid additional charges. Vehicles not returned by 11:00 AM will be charged a late fee of **\$10.00 per hour**. This late fee will not be greater than the daily rental charge for the vehicle rented.

If you are unable to return your vehicle at the scheduled time, please contact us immediately.





INSURANCE

FMI is a registered **Commercial Rental Operation**. We rent trucks to companies and/or individuals carrying **commercial** vehicle insurance.

A Certificate of Insurance listing FMI Truck Sales & Service as an additional insured is required prior to taking delivery of a rental vehicle. If you provide us with the name and phone number of your insurance agent, we will gladly obtain the needed insurance coverage and documents required to rent one of our vehicles.
